ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the City of Woodinville from January 1, 2011 through December 31, 2011.

We evaluated internal controls and performed audit procedures on the activities of the City. We also determined whether the City complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Interlocal agreements
- General disbursements
- Payroll
- Small and attractive assets

RESULTS

In the areas we examined, the City's internal controls were adequate to safeguard public assets. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

The City's 57 full- and part-time employees provide an array of services including parks and recreation, public works, community development and permitting.

AUDIT HISTORY

We audit the City annually. The past five audits of the City reported two findings. The 2008 audit reported a misappropriation of public resources totaling \$78,827. The 2009 audit reported a weakness in internal controls over federal grant compliance. Both issues have been resolved.
