ORDINANCE NO. 27

AN ORDINANCE OF THE CITY OF WOODINVILLE, WASHINGTON, ADOPTING TITLE 23 OF THE KING COUNTY CODE RELATING TO ENFORCEMENT OF LAND USE AND HEALTH ORDINANCES; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the following ordinance is in the best interest of the public health, safety and general welfare, NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Enforcement Provisions Adopted. Except as modified by this ordinance, Title 23 of the King County Code, one copy of which has been and is on file in the office of City Clerk for use and examination by the public, is hereby adopted by this reference as if set forth in full.

Section 2. Modifications to Enforcement Provisions. Title 23 of the King County Code, as adopted by reference herein is hereby modified as follows:

- A. References to King County shall be to the City of Woodinville.
- B. References to Director shall be to the City Manager or other official as designated by the City Manager.
- C. References to Hearing Examiner shall be to the City of Woodinville Hearing Examiner.
- D. References to land use ordinances and public health ordinances shall be to existing or future City ordinances which the

City regulates the use and development of land or which regulate the public health.

E. Section 23.08.020(A) is deleted.

F. Section 23.08.070 is deleted.

G. The civil penalties set forth in Section 23.08.110(A) and 23.08.110(B) shall be a maximum of \$500.00 per violation.

H. Chapter 23.24 is hereby deleted.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective date. This ordinance shall be effective as of March 31, 1993, which is more than five (5) days after publication of an approved summary consisting of the title to this ordinance.
