

ORDINANCE NO. 84

AN ORDINANCE OF THE CITY OF WOODINVILLE,
WASHINGTON, ADOPTING THE 1993 COMPREHENSIVE
SEWER PLAN OF THE WOODINVILLE WATER DISTRICT.

WHEREAS, the City of Woodinville lies within the defined sewer service area of the Woodinville Water District; and

WHEREAS, the Comprehensive Sewer Plan of the Woodinville Water District has identified the short term capital improvements, and the long term planning goals and service criteria to serve as a guide for policy development and decision making processes; and

WHEREAS, the Growth Management Act requires that the sewer plans conform with the land use, transportation and other elements of the City's Comprehensive Plan; and

WHEREAS, the City has adopted an Interim Comprehensive Plan and is beginning the process of enacting its permanent Comprehensive Plan; and

WHEREAS, the City intends its Comprehensive Plan to be the controlling plan in the event of conflicts; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:


Section 1. That the document defined as the Woodinville Water District 1993 Comprehensive Sewer Plan, a copy of which has been given Clerk's Receiving No. 197, is hereby adopted as the Comprehensive Sewer Plan for the City of Woodinville; provided, however, that in the event said Comprehensive Sewer Plan conflicts with the City's Interim or Final Comprehensive Plan, the provisions and intent of the City's Comprehensive Plan shall control.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance or a summary thereof consisting of the title shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after publication.


