

ORDINANCE NO. 192

AN ORDINANCE OF THE CITY OF WOODINVILLE, WASHINGTON, AMENDING THE CITY OF WOODINVILLE ORDINANCE NO. 62 BY MAKING ADJUSTMENTS IN THE SALARY PAID TO MEMBERS OF THE CITY COUNCIL, AND SETTING AN EFFECTIVE DATE.

WHEREAS, the City of Woodinville is a noncharter code city organized and existing under the provisions of Title 35A of the Revised Code of Washington; and

WHEREAS, the Woodinville City Council adopted Ordinance No. 62, establishing the salaries for all City Councilmembers elected or appointed to serve terms and establishing an effective date on June 14, 1993;

WHEREAS, based upon a review of compensation paid to elected officials of comparable cities, an increase in the salary applicable to the City Council is now recommended;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

**Section 1.** Section 1 of Ordinance No. 62 is hereby amended to read as follows:


**Section 1. Council Salaries.** The salary to be paid to Woodinville City Councilmembers shall be \$400.00 per month plus an additional \$100.00 per month for serving as Mayor until January 1, 2000, at which time the salaries shall be increased to \$600.00 per month with an additional \$100.00 for serving as Mayor.

**Section 2. Severability.** Should any section, paragraph, sentence, clause, or phrase of this ordinance be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause, or phrase of this ordinance.


**Section 3. Effective Date.** This ordinance or a summary thereof shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
