

ORDINANCE NO. 461

AN ORDINANCE OF THE CITY OF WOODINVILLE, WASHINGTON, AMENDING ORDINANCE NO. 95 AND SECTION 10.06.050(2) OF THE WOODINVILLE MUNICIPAL CODE, BY REDUCING THE SPEED LIMIT ON 156TH AVENUE NE, FOR 900 FEET NORTH OF NE WOODINVILLE-DUVALL ROAD FROM 35 MPH; AND PROVIDING FOR SEVERABILITY, SUMMARY PUBLICATION, AND AN EFFECTIVE DATE.

WHEREAS, the City of Woodinville adopted Ordinance No. 95 on March 13, 1995 establishing Speed Limits on certain streets and roads within its corporate limits; and

WHEREAS, a speed limit of 35 miles per hour was established for 156th Avenue NE between NE Woodinville-Duvall Road and the north City; and

WHEREAS, development and changing surrounding land use has increased the traffic on 156th Avenue NE in the 900 feet just north of NE Woodinville-Duvall Road potentially creating more conflicts between cars entering 156th Avenue NE and through traffic using 156th Avenue NE; and

WHEREAS, the measured stopping sight distance for a portion of the south 900 feet of 156th Avenue NE north of NE Woodinville-Duvall Road is less than is required for a posted speed limit of 35 miles per hour;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Speed limit 35 MPH. Section 10.06.050(2) of the Woodinville Municipal Code is hereby amended, to read as follows:

“(2) 156th Avenue NE between 900 feet north of NE Woodinville-Duvall Road and the north City Limits.”

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.




