

**ORDINANCE NO. 502**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, AMENDING ORDINANCE NO. 495 TO CHANGE THE DENTAL INSURANCE BENEFIT COVERAGE FOR NON-REPRESENTED EMPLOYEES AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, Ordinance No. 495 adopted by the City Council on December 1, 2009 established pay ranges and benefits for Non-Represented Employees for calendar year 2010; and

**WHEREAS**, Ordinance No. 495 established that Non-Represented Employees would receive dental insurance coverage during 2010 under the Association of Washington Cities Plan A (AWC Plan A) a Washington Dental Service dental coverage program; and

**WHEREAS**, the Non-Representative Employees have evaluated and considered alternative dental coverage programs that desire to switch to AWC Washington Dental Service Plan F (Plan F); and

**WHEREAS**, any increase in costs during 2010, associated with switching to Plan F, shall be borne entirely by the affected employees;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DOES ORDAIN AS FOLLOWS:**

**Section 1.** The City Council hereby amends Ordinance No. 495, Attachment B Dental Benefits for Non-Represented Employees as follows:

"Dental – Willamette Dental \$10 Co-pay

or


the City will provide AWC Washington Dental Service Plan F, which will replace AWC Washington Dental Service Plan A (100% Employee and Dependent Coverage), as of June 1, 2010. Any increased costs between Plan A and Plan F (i.e., premiums, co-pays, etc) will be borne entirely by the employee."

**Section 2.** The AWC Washington Dental Service Plan F dental insurance benefits shall become effective June 1, 2010 and continue until amended by action of the City Council.


