

ORDINANCE NO. 624
AN ORDINANCE OF THE CITY OF WOODINVILLE, WASHINGTON,
AMENDING ATTACHMENT B OF ORDINANCE NO. 618 TO MODIFY THE CITY
MANAGER'S AUTOMOBILE AND TECHNOLOGY ALLOWANCE.

WHEREAS, the City Council previously adopted Ordinance No. 618 to establish authorized positions, pay ranges, and benefits for city employees for 2016; and

WHEREAS, the City Council entered into an employment agreement with a new City Manager in January of 2016; and

WHEREAS, the City Manager employment agreement stipulates a different automobile and technology benefit than what was adopted by the City Council in Ordinance No. 618;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1: Attachment B, Section 4.8 of Ordinance No. 618 shall be amended as follows, with new text shown by underline; and deleted text shown by strikethrough.

4.8 Automobile and Technology Allowance

The City will provide a monthly automobile allowance to defray the cost of using a personal vehicle for Woodinville business within 40 miles of Woodinville city limits. Travel beyond 40 miles will be reimbursed at normal Woodinville mileage rates.~~in lieu of mileage reimbursement and use of city-owned vehicles and equipment, including but not limited to: vehicles, cellular telephones and take-home computers.~~

- City Manager: ~~\$200~~ \$400 per month
- Department Heads as determined by the City Manager: \$100 per month

Section 2. All other provisions of Ordinance No. 618 shall remain unchanged unless amended by the Woodinville City Council by subsequent action.

Section 3. Effective date. This ordinance shall be effective five (5) days after publication of an approved summary consisting of the title to this ordinance.




