RESOLUTION NO. 87

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, AMENDING RESOLUTION 83, SETTING A HEARING DATE TO CONSIDER VACATION OF A PORTION OF 148TH AVENUE NE RIGHT-OF-WAY

WHEREAS, a petition signed by the owners of more than two thirds of the property abutting upon property dedicated for street purposes, located in the City of Woodinville, Washington, being a portion of 148th Avenue NE, and more particularly described on Exhibit "A", attached hereto and incorporated in full by this reference, was filed with the City Clerk/Treasurer of the City for the vacation of the above described property and who has returned a certification of sufficiency; and

WHEREAS, state law in RCW 35.79 requires a hearing on such petition and that the date of such hearing must be fixed by resolution of the City Council, and

WHEREAS, the hearing of this matter was originally scheduled by Resolution 83 of the City of Woodinville for November 28, 1994; and


WHEREAS, in order that the City comply with State public hearing noticing requirements it is necessary to reschedule this public hearing, NOW, THEREFORE,



Exhibit A

That portion of the Northeast quarter of the Southeast quarter of Section 3, Township 26 North, Range 5 East, W.M., and that portion of the Northwest quarter of the Southwest quarter of Section 2, Township 26 North, Range 5 East, W.M., described as follows:

Beginning at the Northeast corner of the South half of the Northeast quarter of the Northeast quarter of the Southeast quarter of said Section 3; thence S 88°56'11" E 30.00 feet to the Easterly margin of 148th Ave. N.E.; thence S 0°32'12" W along said Easterly margin 296.80 feet to the Northerly margin of N.E. 192nd Street; thence N 88°34'49" W along the Westerly projection of said Northerly margin 30.00 feet to the centerline of 148th Ave., N.E.; thence S 0°32'12" W along the centerline of said 148th Ave. N.E. 31.49 feet to the beginning of a non-tangent curve the radius point of which bears S 33°24'14" E for 120.00 feet; thence counter-clockwise along said curve having a radius of 120.00 feet through a central angle of 19°59'34" an arc distance of 41.87 feet to the Westerly margin of 148th Ave., N.E.; thence N 0°32'12" E along said Westerly margin 357.29 feet to a point which bears N 88°56'11" W from the point of beginning; thence S 88°56'11" E 30.00 feet to the point of beginning;
