

## RESOLUTION NO. 224

### A RESOLUTION OF THE CITY OF WOODINVILLE, WASHINGTON, ACCEPTING THE DEDICATION OF PRIVATE STREETS TO PUBLIC STREETS IN THE CHATEAU WOODS/HIGHLANDS.

**WHEREAS**, private to public road conversion was created in response to residences requesting the City provide public services on private streets; and

**WHEREAS**, Ordinance No. 236 was adopted 12 July 1999 establishing a set of minimum criteria and a process for private streets to be accepted as public streets; and

**WHEREAS**, Ordinance No. 309 was adopted 10 December 2001 amending Ordinance No. 236 to allow for a variance to the right-of-way standards; and

**WHEREAS**, Chateau Woods/Highlands has met all the criteria, including a variance for right-of-way width; and

**WHEREAS**, on 4 February 2002, the City Council adopted Resolution No. 214, approving the petition for Chateau Woods/Highlands for the conversion of their private streets to public streets; and

**WHEREAS**, Chateau Woods/Highlands has successfully completed the necessary documentation deeding the private streets and right-of-way to the City of Woodinville; and **NOW, THEREFORE**,

**THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON,  
DOES RESOLVE AS FOLLOWS:**


1. Road Conversions - That the following private streets shall be accepted by the City of Woodinville as public streets:

- 135<sup>th</sup> Court NE (PSL #48)
- NE 146<sup>th</sup> Lane (PSL #49)
- NE 148<sup>th</sup> Street (PSL #51)
- 134<sup>TH</sup> Court NE (PSL #53)
- 137<sup>th</sup> Lane NE (PSL #56)
- 138<sup>th</sup> Way NE (PSL #66)
- NE 146<sup>th</sup> Street (PSL #67)
- 136<sup>th</sup> Place NE (PSL #68)


2. Condition - "No Parking" shall be posted along one side of all the roadways listed in Section 1 of this Resolution. The "No Parking" zones shall be on the side of the sidewalk or as determined by the City Engineer to provide the greatest public safety.
