

RESOLUTION NO. 245

A RESOLUTION OF THE CITY OF WOODINVILLE, WASHINGTON, CALLING FOR AN ELECTION ON THE QUESTION OF ANNEXING .44 ACRES OF LAND LOCATED ON THE CORNER OF NE 171ST STREET AND 142ND AVE NE, SOUTH OF THE CITY BOUNDARY AND COMMONLY KNOWN AS THE VITULLI ANNEXATION; PROVIDING FOR THE SUBMISSION OF A PROPOSITION TO THE VOTERS OF SAID ANNEXATION AREA REQUIRING THE PROPERTY TO BE ASSESSED AND TAXED AT THE SAME RATE AND ON THE SAME BASIS AS OTHER PROPERTY WITHIN THE CITY UPON ANNEXATION; AND REQUIRING THE SIMULTANEOUS ADOPTION OF PROPOSED ZONING REGULATIONS.

WHEREAS, on November 12th, 2002, the City of Woodinville received a Petition for Annexation (Election Method) to annex certain real property *commonly known as the Vitulli Annexation, and*

WHEREAS, The petition is sufficient under the rules set forth in RCW 35A.01.040, calling for an election to vote upon the annexation of unincorporated territory contiguous to the City of Woodinville, and

WHEREAS, pursuant to RCW 35A.14.020, the petition is signed by qualified electors resident in such territory equal in number to ten percent of the votes cast at the last state general election, and

WHEREAS, the City Council has determined that an election should be called, **NOW, THEREFORE,**

THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. Call for Election. Pursuant to RCW 35A14.015, the City Council hereby calls for an election to be held in order to submit a proposal to the voters of the territory commonly know as the Vitulli Annexation Area for annexation into the City of Woodinville. The City Council hereby finds that such annexation would serve the best interest and general welfare of the City.

Section 2. Election Date. The City Council respectfully requests that the Director of the King County Department of Records and Elections set the election called for in Section 1 for September 16, 2003.

Section 3. Description of Boundaries. The boundaries of the Vitulli Annexation Area are described as set forth in Attachment B, and shown on the map, Attachment C, attached hereto and incorporated herein by this reference as if set forth in full.

Section 4. Voters. The number of voters residing within the area to be annexed is two (2).

Section 5. Cost of Election. The City of Woodinville will pay the cost of the annexation election.

Section 6. Assessment and Taxation. At the same election as is called for in Section 1, a separate proposition shall be submitted to the electorate of the Vitulli Annexation Area that all property within such territory shall, upon annexation, be assessed and taxed at the same rate and on the same basis as the other property within the City is assessed and taxed to pay for the then-outstanding indebtedness.

Section 7. Simultaneous Adoption of Zoning Regulations. The City has, pursuant to RCW 35A.14.330 and .340, prepared and filed zoning regulations for the Vitulli Annexation Area. The City Council hereby conditions the annexation upon the simultaneous adoption of those regulations which shall read as set forth in Exhibit C which is attached hereto and incorporated herein by reference as if set forth in full. Such regulations shall become effective for the Vitulli Annexation Area upon annexation of the same to the City.


Section 8. Ballot Proposition. The City Attorney and City Clerk are hereby directed to work with the King County Department of Records and Elections in order to draft the ballot propositions to be submitted to the voters as provided in Sections 1 and 6 above.

Section 9. Boundary Review Board. The Planning Director is hereby directed to prepare and submit a notice of intent to annex the Vitulli Annexation Area to the Washington State Boundary Review Board for King County.

Section 10. Certified Copies. The City Clerk is authorized and directed to file certified copies of this Resolution with the King County Council, the Washington State Boundary Review Board for King County, and the King County Department of Records and Elections.


