

RESOLUTION NO. 370

A RESOLUTION OF THE CITY OF WOODINVILLE WASHINGTON OFFICIALLY NAMING FIVE PARK AND RECREATION PROPERTIES AS FOLLOWS: GEORGIAN HEIGHTS WETLAND TRAIL; GREENBRIER NEIGHBORHOOD PARK; TANGLIN RIDGE VIEW PARK; WEST SAMMAMISH VALLEY VIEW PARK; AND STONEHILL MEADOWS NEIGHBORHOOD PARK.

WHEREAS, Resolution No. 327, adopted by the Woodinville City Council on October 9, 2006 establishes a process and criteria to name city parks, recreation centers, bridges, and other man-made structures; and

WHEREAS, the City of Woodinville currently has at least eight open space properties that have not been officially named; and

WHEREAS, the City of Woodinville conducted a number of public involvement campaigns between March 2009 and June 2009 to allow the public to submit names for these eight unnamed sites; and

WHEREAS, on July 9, 2009, the Woodinville Parks and Recreation Commission reviewed and discussed the names submitted by the public for these sites; and

WHEREAS, after due consideration of the submitted names, consideration of the criteria specified in Resolution No. 327; and discussion by the Parks and Recreation Commission, the Parks and Recreation Commission submitted names for five of the eight unnamed sites to the Woodinville City Council for consideration; and

WHEREAS, in accordance with Resolution No. 327, these recommended names fulfill the criteria of being a "neighborhood or geographical identification" and/or "natural or geological feature"; and

WHEREAS, prior to making a selection to name a site, the Woodinville City Council has received a written recommendation from the Woodinville Parks and Recreation Commissions.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODINVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Naming of Five Sites. The following names shall become the official names of the five sites, more particularly shown in the map, attached hereto, as Exhibit A:

1. Georgian Heights Wetland Trail
2. Greenbrier Neighborhood Park
3. Tanglin Ridge View Park

4. West Sammamish Valley View Park
5. Stonehill Meadows Neighborhood Park

Section 2. Installation of Signs. The City Manager is authorized to install signs at these sites, subject to available budgetary resources and compliance with applicable city rules and regulations.

Section 3. Effective Date. These actions shall become effective September 9, 2009.

Section 4. Severability. If any section, sentence, clause, or phrase of this Resolution or any resolution adopted or amended hereby, should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phase of this Resolution.
